BEGINNING at an iron pin in the center of a road, said pin being in the dividing line between property of the grantor and grantee and running thence S. 34-05 W. 205.5 feet to bend; thence S. 23-35 W. 465 feet to pin, corner of other property of grantor; thence S. 85-05 W. 284.7 feet to iron pin in line of property of W. A. Harrison; thence with the line of Harrison property, N. 19-20 E. 676.5 feet to iron pin thence continuing with the line of the Harrison property, S. 87-15 E. 362 feet to pin in center of road, the point of beginning, containing 4.37 acres.

All that piece, parcel or tract of land in Oaklawn Township, Greenville County, State of South Carolina, made up of five (5) separate tracts constituting as a whole 20.40 acres, as shown on a plat of the PROPERTY OF GEORGE ARNOLD made by C. Harrison and running thence N. 85-22 E. 284.7 feet to an iron pin; thence N. 23-52 E. 401.6 feet to an iron pin; thence N. 81-25 W. 61 feet; thence running N. 34-22 E. 205.5 feet; running thence S. 86-58 E. 11 49 feet; thence S. 1-17 E. 533.3 feet along line of property of Alberson; running thence S. 87.13 W. 582.8 feet; thence S. 84-30 W. 533.2 feet; thence S. 31-30 W. 346.4 feet; thence N. 82-16 W. 161.3 feet; thence N. 19-37 E. 371.5 feet to an iron pin, the beginning corner. This property is bounded on the north by property of W. A. Harrison; on the west by property of John L. King, Jr. and W. A. Harrison; on the south by J. T. Thurmond and on the east by W. A. Harrison.
