MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Lester K. Chrisman and Phyllis A. Chrisman ----- (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty-Four

Thousand Five Hundred and No./100 ----- (\$ 24,500.00 -----)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of Two Hundred Four and 93/100 ----- (\$ 204.93 -----)

per annum, payable monthly in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable --20-- years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the southwestern corner of the intersection of Covington Road and Queensbury Road and known and designated as Lots Nos. 149 and 137 of a subdivision known as Northwood Hills, Section 3, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book YY at Page 37 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Queensbury Road at the joint corner of Lots Nos. 137 and 138 and running thence with the joint line of said lots N. 68-29 W., 147.3 feet to an iron pin at the joint rear corner of Lots Nos. 137 and 149; running thence with the rear line of Lot No. 149 S. 47-56 W., 95.4 feet to an iron pin at the joint rear corner of Lots Nos. 148 and 149; running thence N. 29-17 W., 190 feet to an iron pin on the southern side of Covington Road; running thence with the southern side of said road the following courses and distances, to-wit: N. 65-20 E., 63.3 feet; N. 89-06 E., 112.7 feet; S. 87-45 E., 173.3 feet to an iron pin at the intersection of said road with Queensbury Road which intersection is curved the chord of which is S. 34-04 E., 29.5 feet to an iron pin on the western side of Queensbury Road; running thence with the western side of said road S. 19-37 W., 113.2 feet; thence continuing with said road S. 24-08 W., 50 feet to an iron pin, point of beginning.
