on the Western side of Cherokee Drive, and shown as Lot No. 7 on plat  
No. 2 of West Georgia Heights Subdivision, which plat is recorded in  
the RMC Office for Greenville County in Plat Book WW, at page 149, and  
having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Cherokee Drive, at the  
joint front corner of Lots 7 and 8, and running thence with the joint  
line of said Lots, N. 89-47 W. 200 feet to an iron pin at the rear of  
Lot No. 15; thence with the line of Lot No. 15, N. 0-35 E. 82.7 feet  
to an iron pin on the line of property of James W. Henderson; thence
