133 of Conestee as shown by a plat thereof made by R. E. Dalton, Engineer,  
dated December, 1943, recorded in the RMC Office for Greenville County,  
South Carolina in Plat Book K at Page 276, said lot having such metes  
and bounds, courses and distances as are shown on said plat. This  
property is subject to the Easements, Reservations, and Limitations  
that are set forth in the deed of the to Blackinton Mills, Inc., recorded
