THIS INDENTURE WITNESSETH that Mortgagor (all, if more than one) to secure payment of a Promissory Note of even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagee") in the above Amount of Mortgage and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee the following described real estate together with all improvements thereon situated in South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, Being known and designated as Lot No. 43 on a plat of Sans Souci Annex, recorded in Plat Book "C", at page 29, R.M.C. Office for Greenville County, South Carolina, and having according to said plat the following metes and bounds to-wit:

BEGINNING at a point on the northwest side of Interurban Ave., at joint front corner of Lots Nos. 43 and 44 and running thence with the line of said lots N. 42-20 W. 157.5 feet to a point on a 10 foot alley; thence with said alley S. 42-40 W. 50 feet to pin at joint rear corner of lots Nos. 42 and 43; thence with the line of said lots S. 42-20 E. 157.5 feet to point on Interurban Ave; thence with said Ave. N. 42-40 E. 50 feet to the beginning corner

TO HAVE AND TO HOLD all and singular the premises described above unto the said Mortgagee, his successors and assigns forever

If the Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, assessments and charges against the above-described premises.

Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to the Mortgagee in Mortgagee's favor, and in default thereof Mortgagee may effect (but is not obligated) said insurance in its own name.

Any amount which Mortgagee may expend to discharge any tax, assessment, obligation, covenant or insurance premium shall be a charge against Mortgagor with interest at the highest lawful rate and shall be an additional lien on said mortgaged property, and may be enforced and collected in the same manner as the principal debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage, by suit or otherwise, to pay a reasonable attorney's fee and any court costs incurred which shall be secured by this mortgage and included in judgment of foreclosure.
