TO ALL WHOM THESE PRESENTS MAY CONCERN:

H. JERRY BALDING AND MARGARET V. BALDING

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **TWENTY-FIVE THOUSAND AND NO/100THS**-----

DOLLARS (\$ 25,000.00), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, being a tract of land in **O'Neal Township** containing **10.52 acres** as shown on plat of **Frank and Lucy S. Hall** recorded in the **R. M. C. Office** for **Greenville County** in **Plat Book 4-A, page 183**, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in Langley Road at the corner of a private drive as shown on said plat, and running thence along Langley Road S 66-30 W 157.5 feet to an iron pin; thence N 57-52 W 178.5 feet to an iron pin; thence S 89-08 W 598 feet to an iron pin in the old road at the intersection of the creek; thence following the creek as the line, the traverses and distances of which are N 10-50 W 320 feet; N 47-15 E 625 feet; thence along the 8.1 acre tract S 44-28 E 423.1 feet to an iron pin; thence along the private drive S 23-28 E 500 feet to the point of beginning, together with the right of ingress and egress over said private drive and being the same property conveyed to us in Deed Book 867, page 6.
