until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Jones, and running thence along said Street, N. 41-33 E. 63.8 feet to an iron pin; thence continuing along said Street, N. 82-31 E. 101.2 feet to an iron pin; thence continuing along said Street, N. 86-02 E. 185.4 feet to a point; thence through the said property in a southerly direction 431 feet, more or less, to a point, which point is 145 feet from the front corner with property of McCarter Presbyterian Church; thence S. 82-00 W. 274.4 feet to an iron pin; thence along the line of property of Clyde E. Jones, N. 8-57 W. 448.3 feet to an iron pin, the point of beginning.
