"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated on plat entitled "Property of Bertha C. Sullivan" dated May 25, 1970, prepared by Carolina Engineering & Surveying Co. and recorded in the RMC Office for Greenville County in Plat Book 4-E at Page 13. According to said plat this lot is located on the westerly side of Stafford Street and McGarity Street and fronts 66.5 feet on the southwesterly side of Stafford Street, 50 feet on the northwesterly side of McGarity Street, and being 50.1 and 66.5 feet on the other two sides.
