WHEREAS:

Douglas Wilson & Co. -----, a corporation organized and existing under the laws of South Carolina -----, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fifteen Thousand Four Hundred and No/100 ----- Dollars (\$ 15,400.00 -----), with interest from date at the rate of Eight and One-half -- per centum (8 1/2%) per annum until paid, said principal and interest being payable at the office of C. ALL that piece, parcel or lot of land situate, lying and being on the southern side of Sherman Lane near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as the property of Eugene A.
