All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 28 of a subdivision known as Edwards Forest Heights as shown by plat thereof prepared by Jones Engineering Service, February 1967, recorded in the R. M. C. Office for Greenville County in Plat Book OOO at Page 87 and having, according to said plat, the following metes and bounds, to-wit:
