WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Eleven Thousand, Five Hundred and No/100----- (\$ 11,500.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments & as set out in said note.

Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 154 according to a plat of a subdivision entitled "Addition to Coleman Heights" dated April 24, 1964, prepared by Piedmont Engineers and Architects, and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 161 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Keeler Bridge Road at the joint front corner of Lots Nos. 154 and 155 and running thence with the line of Lot No. 155, N. 48-55 W. 120 feet to an iron pin at the corner of Lot No. 153; thence with the line of Lot No. 153, N. 21-28 W. 123 feet to an iron pin on the southern side of Alta Vista Circle; running thence with the southern side of Alta Vista Circle N. 86-08 E. 100 feet and N. 89-20 E. 175 feet to an iron pin at the intersection of Alta Vista Circle and Keeler Bridge Road; running thence with the curvature of said intersection, the chord of which is S. 21-44 E. 30.7 feet and running thence with the northern side of Keeler Bridge Road, S. 41-05 W. 230 feet to the point of beginning; being the same conveyed to W R Corporation by Stanley I.
