NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot 12 on a Plat of Barwood Subdivision, recorded in Plat Book 000, Page 33, R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly edge of Barwood Circle, joint front corner of lots 11 and 12 and running thence with the line of Lot 11, N. 28 W., 200 ft. to an iron pin; thence S. 59-20 W., 109.75 ft. to an iron pin; thence S. 33-38 E., 205 ft. to a point on the Northwesterly edge of Barwood Circle; thence along the edge of said Circle, N. 56-22 E., 90 ft. to the point of beginning.
