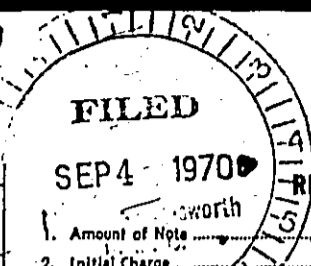

NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville and State of South Carolina, to-wit: All that piece, parcel or lot of land, situate lying and being about three miles north of the City of Greenville in the County of Greenville, State of South Carolina being known and designated as Lot NO. 10, property of Ethel Y Perry Estate, San Souci Section, on King Street between McMarin Drive and Dukaland Dr., as per plat thereof recorded in the RMC office for Greenville County in Plat Book S, Page 49 of a five foot sidewalk running along King Street and Having the following metes and bounds: to-wit; Beginning at an iron pin on the western edge of a five foot sidewalk running along King Street said pin being the join front corner of Lots Nos. 9 and 10; thence along the western side of said sidewalk, S31-27E.65 feet to an iron pin joint front corner of Lots Nos. 10 and 11; thence along the northern side of Lot No. 11 S75-25W.174.6ft to an iron joint rear corner of Lots Nos. 9 and 10 thence along the Southern line of Lot No 9, N.70-39E.152.2 feet to an iron pin, the point of beginning.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.
