"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Northerly side of Ashley Avenue(now or formerly known as South Woodside Circle) being known and designated as Lots Nos. 74 and 75 as shown on plat entitled "Woodside Circle", prepared by C. M. Furman, Engineer, dated March 25, 1920, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book E at Page 219, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northerly side of Ashley Avenue (formerly South Woodside Circle) at the joint front corner Lots 73 and 74, and running thence along line of Lot 73, N. 28-30 E. 135.8 feet to an iron pin; thence N. 65-49 W. 50 feet to an iron pin, joint rear corner Lots 75 and 76; thence S. 28-30 W. 150 feet to an iron pin on Ashley Avenue; thence along Ashley Avenue, S. 65-49 E. 15 feet to a point; thence continuing along Ashley Avenue, S. 87-15 E. 38 feet to an iron pin, the point of beginning.
