(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **SIXTEEN THOUSAND SEVEN HUNDRED AND NO/100THS--**

DOLLARS (\$ 16,700.00), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as Lot 15, Section V, on plat of Richmond Hills recorded in the R. M. C. Office for Greenville County in Plat Book WW, at page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Konnarock Circle at the corner of Lot No. 14, and running thence N 62-24 W 150 feet to an iron pin; thence N 27-36 E 100 feet to an iron pin in a County Road; thence along the southern side of said Road S 62-24 E 125 feet to an iron pin; thence with the intersection of Konnarock Circle and said County Road S 17-24 E 35.35 feet to an iron pin on the western side of Konnarock Circle; thence with said Circle S 27-36 W 75 feet to the point of beginning.
