WHEREAS, the Mortgagor is well and truly indebted unto UNITED MORTGAGEE SERVICING CORP. a New York Corporation, with principal place of business at 3200 Pacific Avenue, Virginia Beach, Virginia

, a corporation organized and existing under the laws of New York hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twelve Thousand Eight Hundred and No/100----- Dollars (\$ 12,800.00), with interest from date at the rate of eight and one-half per centum (8½ %) per annum until paid, said principal and interest being payable at the office of United Mortgagee Servicing Corp. in Virginia Beach, Virginia

or at such other place as the holder of the note may designate in writing, in monthly installments of Ninety-Eight and 43/100----- Dollars (\$ 98.43), commencing on the first day of November, 19 70, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of October 2000

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as the major portion of Lot No. 10 and a small triangular portion of Lot No. 11, Block G, Woodville Heights, as shown on a plat thereof of record in the Office of the RMC for Greenville County in Plat Book L, Pages 14 and 15, and being more specifically shown on a plat entitled "Property of Larry E. Turner" prepared by R. B. Bruce, RLS, said plat being of record in the Office of the RMC for Greenville County in Plat Book 41, Page 27, reference to said latter plat being craved for a metes and bounds description thereof.

The grantor covenants and agrees that so long as this mortgage is and the note secured hereby are guaranteed under the Servicemen's Readjustment Act, or insured under the provisions of the National Housing Act, he will not execute or file for record any instrument which imposes a restrictions upon the sale or occupancy of the subject property on the basis of race, color or creed. Upon violation of this covenant, the note holder may, at its option, declare the unpaid balance of the debt secured hereby immediately due and payable.
