"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 33 on a plat of North Gardens Subdivision of record in the Office of the RMC for Greenville County in Plat Book EE, Page 63, reference to said plat being graved for a metes and bounds description thereof.

This mortgage is second and junior in lien to that mortgage in favor of Canal Insurance Company of record in the Office of the RMC for Greenville County in R. E. M. Book 625, Page 231.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
