To All Whom These Presents May Concern: We, Hubert C. Moon, Jr. and

Gail S. Moon, - - - - - (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - - - -

- - - - -ONE THOUSAND TWO HUNDRED AND NO/100- - - - -  
DOLLARS (\$ 1,200.00- - ), with interest thereon from date at the rate of - - -eight - - -  
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, located about three (3) miles northeast of the City of Greer, on the north-west side of the Miller Bridge Road, being shown on a plat made for Hubert C. Moon, Jr. by G. A. Wolfe, Surveyor, dated May 24, 1969, and having the following courses and distances:

BEGINNING on a railroad spike in the center of said road (iron pin on west bank thereof at 30 feet), corner with property now owned by Hoyt Turner, and runs thence with his line, N. 69-15 W. 250 feet to an iron pin (old corner); thence N. 46-20 W. 62.2 feet to an iron pin; thence N. 43-40 E. 197 feet to an iron pin; thence S. 46-40 E. 293 feet to a railway spike in the center of the Miller Bridge Road (now S. C. Highway #S23-137); thence along and with the center of said road, S. 43-40 W. 100 feet to the beginning, containing 1.08 acres, more or less.

This is the same property conveyed to the mortgagors by deed of Clara Waters, dated June 6, 1969, recorded in Deed Book 869, Page 431, R. M. C. Office for Greenville County.

This mortgage is in addition to one now held by Greer Federal Savings and Loan Association, recorded in Mortgage Book 1159, Page 278, R. M. C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
