All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, lying at the northeastern corner of Russell Avenue and Bennett Street and being known and designated as Lot No. T-16 and the southern adjoining four (4) feet of Lot T-17, as shown on a plat entitled "Property of C. H. Talley" prepared by W. M. Rast, Engineer, in January 1928, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book H at Page 116 and having, according to said plat, the following metes and bounds, to-wit:
