To All Whom These Presents May Concern: I, Marion O. Stokes,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----

----- Five Thousand Five Hundred & No/100 -----
DOLLARS (\$5,500.00), with interest thereon from date at the rate of eight (8%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, approximately three miles northwest of Greer, located on the northeast side of the Old Ansel School Road, containing 0.71 acres, more or less, as shown on a survey entitled Property of Marion O. Stokes, dated October 17, 1970, by John A. Simmons, Registered Surveyor, to be recorded herewith, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail in the center of Old Ansel School Road (new iron pin back at 13 feet), joint corner with other property of Truman Chandler, and running thence N. 53-15 E. 160.6 feet to a new iron pin; thence N. 55-30 W. 380.8 feet to a nail in the center of Old Ansel School Road (old iron pin back at 33.7 feet); and thence with Old Ansel School Road, S. 28-35 E. 238 feet to a nail; thence S. 34-20 E. 125 feet to the point of beginning.

This is the same property conveyed to the mortgagor by deed of Truman R. Chandler and Nola L. Chandler, to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
