That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville:

ALL that lot of land with the buildings and improvements thereon situate on the southeast side of Queensbury Road near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 122 on plat of Section 3 of Northwood Hills, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book YY at Page 37 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Queensbury Road at the joint corner of Lots 121 and 122 and runs thence along the line of Lot 121 S. 32-02 E. 130.2 feet to an iron pin; thence S. 88-37 E. 110.8 feet to an iron pin; thence with the line of Lot 123 N. 12-38 W. 243.3 feet to an iron pin on the southeast side of Queensbury Road; thence with the curve of Queensbury Road (the chord being S. 79-42 W. 19.2 feet) to an iron pin; thence still along Queensbury Road S. 41-43 W. 162 feet to the beginning corner.
