"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Town of Fountain Inn, shown as Lot 8, Block "B", on a Plat of Friendship Heights Subdivision, which Plat is recorded in the R.M.C. Office for Greenville County in Plat Book______, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the center of the intersection of Hellams Street, Extension and Fork Road and running thence with the western side of Hellams Street Estension, S. 3-30 W., 120 ft. to an iron pin at the joint rear corner of lots 8 and 9; thence with the joint line of said lots, N. 86-30 W., 150 ft. to an iron pin on the line of Lot 7; thence along the line of said lot, N. 3-30 E., 72.9 ft. to an iron pin on the Southern side of Fork Road; thence along the side of said lot, N. 76-03 E., 157.7 ft. to an iron pin at the point of beginning.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
