TO ALL WHOM THESE PRESENTS MAY CONCERN:

LINDSEY BUILDERS, INC. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eleven Thousand and No/100-----

DOLLARS (\$ 11,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Kenmore Drive in Gantt Township, Greenville County, S. C., being shown and designated as Lot No. 128 on a Plat of Rockvale Section 1 made by J. Mac Richardson, RLS, dated October, 1958 and recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ, Page 108, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Kenmore Drive at the joint front corner of Lots 126 and 128 and running thence along the common lines of said lots, S. 3-59 W. 165 feet to an iron pin; thence along the line of Lots Nos. 125 and 127, N. 86-01 W. 75 feet to an iron pin; thence along the line of Lot No. 130, N. 3-59 W. 165 feet to an iron pin on Kenmore Drive; thence along the Southern side of Kenmore Drive, S. 86-10 E. 75 feet to an iron pin, the beginning corner.
