WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - -

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located about one mile West of Greer, South Carolina, on the Southern side of Gregory Drive and being shown and designated as all of Lot No. 86 on plat of property entitled "KING ACRES", made by John A. Simmons, Surveyor, dated August 10, 1963, recorded in Plat Book YY, Page 153, Greenville County R.M.C. Office, having a frontage on Gregory Drive of 103.9 feet, a depth on the West side along Lot 85 a distance of 124.4 feet, a rear of 131.1 feet and a depth on the East side along Lot 87 a distance of 179 feet. Reference is hereby made to said plat for a more complete description as to metes and bounds.

Property conveyed subject to restrictions recorded in Deed Book 734, Page 239, Greenville County R.M.C. Office and set back lines and easements as indicated on said plat.
