NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land on Sumner Street in the City of Greenville, and State_aforesaid, and being owned and designated as the major portion of lot number 4 as shown on a plat recorded in Plat Book F, page 20, R. M. C. Office, Greenville County. Described as a whole said lot is shown by courses and distances and metes and bounds;

It begins on the eastern edge of Sumner Street at a point 171.5 feet southward from southern edge of Pendleton Street and runs thence along the line of lots 8 and 1 as shown on the plat above referred to a distance of 143.1 foet to corner of lot now owned by Lindsey; thence along Lindsey line S. 19-12 W. 54 feet to corner on the rear portion of lot number 5 as shown on the said plat; thence along the line of lot number 5 N. 70-27 W. 142.7 feet to corner on the eastern side of Sumner Street, thence along Sumner Street N. 18-45 E. 54 feet to the beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
