(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **FOURTEEN THOUSAND AND NO/100THS**

DOLLARS (\$ **14,000.00**), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as **Lot No. 27 on plat of Grand View Hills recorded in the R. M. C. Office for Greenville County in Plat Book WWV, page 52, and having, according to said plat, the following metes and bounds, to-wit:**

BEGINNING at an iron pin on the northern side of Knoll Circle at the corner of Lot No. 26, and running thence N 40-15 W 200 feet to an iron pin; thence S 49-51 W 139.8 feet to the turn-around of Sunset Street; thence following the curve of same, the chord of which is S 10-07 E 50 feet to an iron pin on the northern side of Sunset Street; thence with said Street, S 40-12 E 131.7 feet to an iron pin; thence along the curved intersection of Sunset Street and Knoll Circle, the chord of which is S 85-10 E 35.9 feet to an iron pin on the northern side of Knoll Circle; thence with said Circle, N 49-51 E 140 feet to the point of beginning and being the same conveyed to me by Murphree C. Donnan by deed to be recorded of even date herewith.
