**DESCRIPTION OF PROPERTY**

Beginning at the point of intersection of the Northerly line of New Bridge Street and the Easterly line of Sumner Street, as shown on said plan; thence Northwesterly on said Sumner Street, one hundred seventy-seven and 55/100 (177.55) feet to the Southwesterly corner of lot 13 (thirteen) as shown on said plan; thence Northeasterly on said Lot 13 (thirteen), two hundred two (202) feet to Cook Street as shown on said plan and the Southeasterly corner of said Lot 13 (thirteen); thence Southeasterly on said Cook Street, one hundred five and 55/100 (105.55) feet to the Northeasterly corner of land now or formerly of one Jonathan Stockwell; thence Westerly along the Northerly line of said land now or formerly of Jonathan Stockwell and the Northerly line of Lot 6 (six) as shown on said plan, sixty-one and 23/100 (61.23) feet to the Northwesterly corner of said Lot 6 (six); thence Southerly by the Westerly line of said lot 6 (six), one hundred (100) feet to said New Bridge Street and thence Westerly on said New Bridge Street, one hundred one and 50/100 (101.50) feet to the point of beginning.
