TO ALL WHOM THESE PRESENTS MAY CONCERN:

LINDSEY BUILDERS, INC. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand and No/100-----

DOLLARS (\$ 7,000.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, Nine months after date,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Warren Court in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot No. 4 on a Plat of WARREN COURT made by Campbell & Clarkson Surveyors, Inc., dated February 17, 1971, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4J, page 23, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Warren Court at the joint front corners of Lots Nos. 3 and 4, and running thence N. 36-27 E., 105.2 feet to an iron pin; thence N. 51-25 W., 57.8 feet to an iron pin; thence along the line of Lot No. 5 and property owned by Alvin Billups, Jr., S. 65-07 W., 130 feet to an iron pin on Warren Court; thence along the Northern side of Warren Court, S. 60-21 E., 68.4 feet to an iron pin; thence continuing along said side of Warren Court, S. 52 E., 51.7 feet to an iron pin, the beginning corner.
