MORTGAGE

WHEREAS:

Harold Glenn Hines and Mary B. Hines, hereinafter called the Mortgagor, is indebted to Greenville, South Carolina

C. Douglas Wilson & Co., a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-four Thousand Two Hundred and No/100 Dollars (\$ 24,200.00), with interest from date at the rate of Seven percentum (7 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Sixty-one Dollars (\$ 161.17), commencing on the first day of May, 1971, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 2001.

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

ALL that piece, parcel or lot of land situate, lying and being on the northeastern side of Hicks Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as a portion of Lot No. 1 of a subdivision of property of Nora C. Crosby, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book TT at Page 73; also shown as the property of Harold Glenn Hines and Mary B. Hines on plat prepared by Carolina Surveying Company which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 4I at Page 61; said lot having such metes and bounds as shown on said latter plat.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
