Office for Greenville County in Plat Book UUU, at page 89, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Dahlgreen Lane at the corner of Lot No. 15, and running thence along said Lane, N 11-20 E 177.9 feet to an iron pin; thence along the curve of said Lane, the chord of which is N 27-30 E 61 feet to an iron pin; thence along the curve of said Lane, the chord of which is N 58-42 E 65.3 feet to an iron pin; thence with said Lane, N 71-26 E 98.1 feet to an iron pin; thence S 11-20 W 329.6 feet to an iron pin; thence N 78-40 W 150 feet to the point of beginning and being the same conveyed to us by deed of Clyde A. and Margaret Z.
