"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville:

All that lot of land in Greenville County, State of South Carolina, shown as Lots 81 and 82 on plat of Paris-Piney Park recorded in Plat Book H at Pages 19 and 20 in the RMC Office for Greenville County and having the following metes and bounds:

BEGINNING at an iron pin on the southern side of Orlando Avenue at corner of Lot 83; thence along line of Lot 83, S. 34-30 W. 150 feet to an iron pin at corner of said lot; thence N. 55-30 W. 100 feet to an iron pin at rear corner of Lot 80; thence along Lot 80 N. 34-30 E. 150 feet to an iron pin on the Southern side of Orlando Avenue; thence along the southern side of said Avenue, S. 55-30 E. 100 Feet to the beginning corner.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
