TO ALL WHOM THESE PRESENTS-MAY CONCERN: Willie C. Chapman and

Beatrice G Chapman ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Three thousand four hundred and 00/100 ----- DOLLARS (\$ 3,400.00 ----), with interest thereon at the rate of eight (8) ---- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is six years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Doe Street being known as Lot 5 on a plat of the property of Minnie B. Christopher dated July 6, 1948, prepared by Pickell and Pickell and recorded in Plat Book U at page 113 in the Office of the R.M.C. for Greenville County and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Northeastern side of Doe Street at the joint front corner of Lot 4 and Lot 5 and running thence with Lot 4 N 23-58 E 62.7 feet to an iron pin at the joint rear corner of Lot 4 and Lot 5; running thence with Lot 3 N 61-23 W 24.8 feet to an iron pin; thence still with Lot 3 N 23-48 E 37.8 feet to an iron pin at the joint rear corner of Lots 2, 3 and 5 and 14; thence with Lot 14 N 64-56 W 15.3 feet an iron pin at the joint rear corner of Lot 5 and Lot 6; thence with Lot 6 S 23-58 E 103.1 feet to an iron pin on the Northeastern side of Doe Street; thence with said street S 66-47 E 40 feet to the point of beginning.

This is the same property conveyed to the Mortgagor by deed recorded in Deed Book 852 at page 354 in the Office of the R.M.C. for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
