TO ALL WHOM THESE PRESENTS MAY CONCERN: I, J. H. Morgan

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of One Hundred Twenty Thousand ----- DOLLARS (\$120,000.00), with interest thereon at the rate of eight & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is three(3) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the northern side of South Carolina Highway 253 and the northwest side of Darby Road, containing 28.95 acres as shown on plat entitled "Property of J. H. Morgan" made by Campbell & Clarkson, Surveyors, Inc. August 4, 1970, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northeast corner of the intersection of South Carolina Highway 253 and Darby Road; thence with the northerly side of said road N. 61-41 E. 615.6 feet to a point; thence N. 65-28 E. 149 feet to a point; thence N. 67-29 E. 220.8 feet to a point; thence continuing with the northerly side of said Darby Road N. 68-43 E. 333.6 feet to an iron pin; thence turning N. 3-00 E. 659.9 feet to an iron pin in line of land of Jonah Smith; thence with the line of said property N. 87-28 W. 1122.1 feet to an iron pin on the southeast side of a county road; thence crossing said road N. 87-28 W. 51.4 feet to an iron pin on the northwest side of said road; thence continuing with the line of Jonah Smith property N. 87-13 W. 182.2 feet to an iron pin in line of Clearview Acres subdivision; thence with the line of said subdivision S. 2-58 W. 467.9 feet to an iron pin on the northwest side of a county road; thence crossing said road S. 2-58 W. 102.5 feet to an iron pin on the southeast corner of said county road, corner of property of Bible Baptist Church; thence with the line of said property S. 2-48 W. 574.1 feet to an iron pin on the northeast side of South Carolina Highway No. 253; thence with the northeast side of said highway S. 52-14 E. 228.5 feet to the beginning corner.

LESS lots 25, 27 and 55 on Darby Road which are not covered by this mortgage as shown on plat of Coachman Estates.
