WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

Greenville, near the City of Greenville, on the West side of Sentell Road and on the South side of Knollview Drive, shown as Lots Nos. 60 and 96 on plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the RMC Office for Greenville County, S.C., in Plat Book KK, page 107 and having, according to said plat, the following met es and bounds, to-wit: BEGINNING at an iron pin on the South side of Knollview Drive at the joint corner of Lots 95 and 96 and runs thence along the line of Lot 95 S 11-16 W 126 feet to an iron pin; thence along the line of Lot 61 S 3-11 E 126 feet to an iron pin on the North side of Sentell Road; thence along.
