BEGINNING at an iron pin on the northwesterly side of Denna Drive, joint front corner Lots 72 and 73, and running thence N. 21-13 W. 170 feet to an iron pin; thence N. 68-47 E. 85 feet to an iron pin; thence S. 21-13 E. 170 feet to an iron pin on Denna Drive; thence along Denna Drive, S. 68-47 W. 85 feet to an iron pin, the point of beginning.
