(hereinafter referred to as Mortgagor) SEND(S) GREETING:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, fronting on Boykins Court and being shown and designated as all of lot number THIRTY THREE (33) on plat of RICHMOND HILLS, SECTION FIVE (5), made by R. B. Bruce, surveyor, dated November 14, 1967, and recorded in plat book "WWW" page 38, Greenville County R. M. C. Office, to which plat reference is hereby made for a more complete description as to metes and bounds.
