"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, shown and designated as Lot No. 94, Buxton Subdivision, according to a plat entitled "Buxton" prepared by Piedmont Engineers and Architects, which is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book 4N, at Pages 2, 3 and 4.
