## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Francis H. Bledsoe and

Mitzi Bledsoe

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN\_ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-nine Thousand Seven Hundred and no/100ths-----DOLLARS (\$ 29,700.00'), with interest thereon at the rate of seven & 3/4 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the eastern side of Pimlico Road, in the City of Greenville, being shown and designated as lot #85 of Section A of Gower Estates, as shown on plat recorded in Plat Book QQ at pages 146-147, and described as follows:

BEGINNING at an iron pin at the joint front corner of lots Nos. 85 and 86, and running thence with the line of lot #86, S. 48 E. 175 feet to pin; thence N. 27-09 E. 166.6 feet to pin; at rear corner of lot #84; thence with line of lot #84 S. 76-41 W. 175 feet to pin on Pimlico Road; thence with the eastern side of Pimlico Road, S. 26-30 W. 80 feet to the point of beginning.
