"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Kenmore Drive, being shown and designated as Lot No. 240 on a plat of ROCKVALE, Section 2, made by J. Mac Richardson, Surveyor, dated July, 1959, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, page 109, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Kenmore Drive at the joint front corners of Lots Nos. 239 and 240, and running thence along said side of Kenmore Drive, N. 86-01 W., 65 feet to an iron pin; thence with the curve of the intersection of Kenmore Drive with Saville Court, the chord of which is N. 40-81 W., 14.6 feet to an iron pin; thence along the Eastern side of Saville Court, N. 4-39 E., 150 feet to an iron pin; thence along the line of Lot No. 234, S. 85-21 E., 75 feet to an iron pin at the joint rear corner of Lots 239 and 240; thence along the common line of said lots, S. 4-39 W., 160.9 feet to an iron pin, the beginning corner.
