

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

George S. Lint and Jo Ann R. Lint

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

Thousand Seven Hundred and No/100----(s 21,700.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note <u>does not contain</u> a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of __One Hundred Fffty

Five and 47/100-----(\$155.47) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon situate, lying and being in the State of South Carolina, County of Green Ville, Austin Township, in the Town of Simpsonville, being known and designated as Lot 77 on a plat of Forest Park, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book EE at Pages 64 and 65, and having according to said plat the following metes and bounds:

Beginning on the Northwestern edge of Forest Park Drive at the joint front corner of Lots 77 and 78 and running thence along a line of Lot 78 N. 3-46 W. 118 feet to the center of a creek; thence with the center of the creek as the line in the Easterly direction (by a traverse line S. 89-46 E. 102.1 feet) to the joint rear corner of Lots 76 and 77: along a line of Lot 76 S. 13-23 E. 111.4 feet to a point on the Northwestern edge of Forest Park Drive; thence along the Northwestern edge of said Drive S. 80-32 W. 52 feet to a point; thence continuing along the Northwestern edge of said Drive S. 86-14 W. 70 feet to the beginning corner.
