WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of . Forty-five Thousand and No/100

DOLLARS (\$ 45,000.00), with interest thereon from date at the rate of seven and one-half (7½%) per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the southwesterly side of Stonehedge Drive, near the City of Greenville, S. C., being known and designated as Lot No. 78 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Stonehedge Drive, said pin being the joint front corner of Lots 78 and 79 and running thence with the common line of said lots S 44-12 W 216.9 feet to an iron pin, the joint rear corner of Lots 78 and 79; thence S 69-23 E 87.4 feet to an iron pin, joint rear corner of Lots 77 and 78; thence with the common line of said lots N 65-37 E 162.6 feet to an iron pin on the southwesterly side of Stonehedge Drive; thence with the southwesterly side of Stonehedge Drive N 26-12 W 77.5 feet to an iron pin; thence continuing with said Drive N 39-00 W 77.5 feet to an iron pin, the point of beginning.
