### MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. B. Barksdale, Georgia Barksdale, and Gloria B. Ervin of Greenville County, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Collateral Investment Company

organized and existing under the laws of ALABAMA, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eight Thousand Five Hundred and no/100 Dollars (\$ 8,500.00--- ), with interest from date at the rate of Seven----- per centum ( 7-----%) per annum until paid, said principal and interest being payable at the office of Collateral Investment Company in Birmingham, Alabama

or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty and 10/100----- Dollars (\$ 60.10----- ), commencing on the first day of August, 1971 and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 1996.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that lot of land being shown as Lot 42 on plat of Dixie Heights recorded in Plat Book H at page 46 in the RMC Office for Greenville County, and fronting on Briarcliff Drive.

The mortgagor covenants and agrees that so long as this mortgage and the said note secured hereby are insured under the National Housing Act he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the mortgaged property on the basis of race, color or creed. Upon any violation of this undertaking, the mortgagee may at its option declare the unpaid balance of the mortgage immediately due and payable.
