To All Whom These Presents May Concern:

WHEREAS, Steve I. Biroczyk and Elizabeth B. Biroczyk -----

hereinafter called the mortgagor(s), is (are) well and truly indebted to Berry's Inc. and H. L. Baumgardner ----- hereinafter called the mortgagee(s),

in the full and just sum of Twenty Thousand Eighty-nine and 85/100 (\$20,089.85) -----

ALL that piece, parcel or lot of land situate, lying and being at the intersection of Fork Shoals Road and a county road and shown as Lots Nos. 1, 2 and 3 on a plat of property of Greenville County Schools prepared by Carolina Engineering & Surveying Co. revised August, 1970 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of Fork Shoals Road with a county road and running thence with the center of said county road N. 83-07 E., 382.7 feet to an iron pin in the line of property now or formerly of the James Estate; running thence with that line S. 32-0 E., 320.8 feet to an iron pin; running thence S. 5-45 E., 118 feet to an iron pin; running thence S. 79-56 W., 320.9 feet to an iron pin on the eastern side of the Fork Shoals Road; running thence with the eastern side of said road N. 31-33 W., 469.5 feet to an iron pin, point of beginning.
