TO ALL WHOM THESE PRESENTS MAY CONCERN: we, James E. Henson and
Hope W. Henson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto WOODRUFF FEDERAL SAVINGS AND
LOAN ASSOCIATION, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note
of even date herewith, the terms of which are incorporated herein by reference in the sum of
SIXTEEN THOUSAND and no/100
DOLLARS (\$16,000.00), with interest thereon from date at the rate as specified in said note, said
principal and interest to be repaid as therein stated, said note provides that the final payment of principal and
interest, if not sooner paid, shall be due and payable on the first day of July 1991, and

Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration
of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at
and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted,
bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its
successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast
side of the Brannon Road about 2 miles West of Greer, in Chick Springs
Township, and being known and designated as lot no. Two (2) of the
James L. and Luannie C. Henson property as shown on plat prepared
by John A. Simmons, Reg. Surveyor, dated May 6, 1960 and which plat
has been recorded in the R. M. C. Office for said County in Plat
Book WW, page 125. This being the same property which was conveyed
to mortgagors herein by James L. Henson and Luannie Catherine Henson
by deed recorded in said office in Deed Book 650, page 393. For a
more particular description see the aforesaid plat.
