TO ALL WHOM THESE PRESENTS MAY CONCERN:

Patricia C. Haskell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twenty-Five Thousand and no/100-----**

DOLLARS (\$ 25,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the East side of Capers Street in the city of Greenville, in Greenville County, S. C. being shown as Lot no. 74 on Plat of Crescent Terrace, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book E Page 137 and having according to said Plat the following metes and bounds, to-wit:**

BEGINNING at an iron pin on the East side of Capers Street at the front corner of Lot 75, N. 84-19 E. 239.7 feet to an iron pin; thence S. 2-08 E. 70.14 feet to an iron pin; thence with the line of Lot 73, S. 84-19 W. 235.5 feet to an iron pin on the East side of Capers Street; thence along the East side of Capers Street, N. 5-41 W. 70 feet to the beginning corner.
