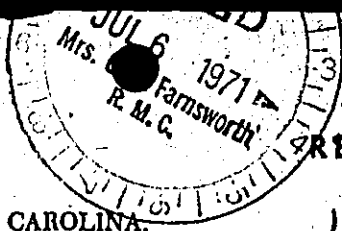

For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, BLUE RIDGE PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by John P. Painter and Helen S. Painter March 10, 1967, 1052 211 to it, on November 3, 1969, recorded in Mortgage Book 1141, page 309, public records of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property:

ALL that lot or parcel of land in Grove Township, Greenville County, State of South Carolina, being a lot on the South Eastern corner of the Home place of John P. Painter, and having the following courses and distances, to-wit:

BEGINNING at an iron pin in the center of a county road, the southeastern corner of Lot, old I.P. 25.5 feet West from a new corner; thence along the Painter line N. 67-05 W. 435.9 feet to an iron pin; thence along a new corner line N. 43-58 E. 110 feet to a new corner; thence along a new line S. 67-05 E. 435.9 feet to an iron pin in the center of said road; thence along center of said road S. 43-58 W. 110 feet to BEGINNING corner, containing one acre, more or less. Bounded on the North and West by land of John P. Painter, on the East by road, on the south by Martin land.

The above described property is part of the tract of land conveyed to John P. Painter by H.L. Lindley by deed dated Aug. 26, 1950, recorded in the R.M.C. Office for Greenville County, S.C. in Deed Book 417 at page 281. Flat recorded in Flat Book D atPg.124. the said mortgage to remain in full force and effect, and in all other respects unchanged as to the rights given therein to the holder of said mortgage.
