(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----

Twenty-seven Thousand and no/100-----
DOLLARS (\$ 27,000.00---), with interest thereon from date at the rate of Seven and three-fourths--
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville-----, being shown as Lot 107 on plat of Del Norte Estates, Section IV, recorded in Plat Book 4N at page 8, and having the following metes and bounds:

Beginning at an iron pin on the southern side of Newtonmore Road at the joint front corner of Lots 106 and 107, and running thence with line of Lot 106, S 4-35 W 143.05 feet to an iron pin; thence S 84-35 E 158.15 feet to an iron pin on the western side of Del Norte Road; thence with the western side of Del Norte Road, N 23-25 W 138.3 feet to an iron pin at corner of Del Norte Road and Newtonmore Road; thence with said corner, N 54-00 W 43.1 feet to an iron pin on the southern side of Newtonmore Road; thence with the southern side of Newtonmore Road, N 84-34 W 56.2 feet to the beginning corner.

Derivation: Same property conveyed to mortgagors by B-T-M Corporation by deed to be recorded herewith.
