TO ALL WHOM THESE PRESENTS MAY CONCERN: DEMPSEY REAL ESTATE CO., INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TEN THOUSAND NINE HUNDRED and no/100-----  
DOLLARS (\$ 10,900.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Lockman Drive in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 87, on a Plat of FORE ESTATES, dated March 1952, prepared by Dalton & Neves, Engineers, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book BB, Page 61, and having according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Southern side of Lockman Drive at the joint front corner of Lots Nos. 86 and 87, thence with the joint line of said lots, S. 14-51 E., 355.2 feet to an iron pin; thence S. 88-17 W., 77.02 feet to an iron pin at the joint rear corner of Lots 87 and 88; thence with the joint line of said lots, N. 14-51 W., 337.8 feet to an iron pin on the Southern side of Lockman Drive; thence with said Drive, N. 75-09 E., 75 feet to an iron pin, the beginning corner.
