per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

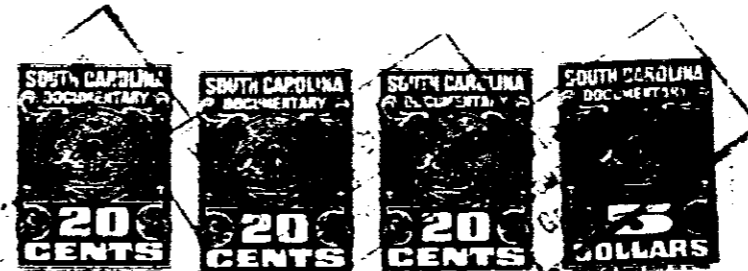

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, being shown as Lot #3 on a Plat of Property of George Young made by C. C. Jones dated February 3, 1958 and having the following metes and bounds, to-wit:

BEGINNING an an iron pin on the Southern side of Reedy Fork Road at the corner of the property of Cornell Sweeney and running thence along the Southern side of Reedy Fork Road S. 46-18 W. 143 feet to an iron pin at the corner of Lot #2; thence S. 41-33 E. 150 feet to an iron pin; thence N. 44-54 E. 120.5 feet to an iron pin; thence along the Sweeney property N. 32-42 W. 150 feet to the point of Beginning.
