C. in plat book JJJ page 44, and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the south side of Blossom Drive, joint front corner of Lots 142 & 141, and running thence with the south side of said Blossom Drive S. 87-18 E. 75 feet to an iron pin, joint front corner of Lots 141 & 140; thence with the joint line of said lots S. 2-42 W. 133 feet to an iron pin; thence N. 87-18 W. 75 feet to an iron pin; thence N. 2-42 E. 133 feet to the point of beginning.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
